**GENERAL INSTRUCTIONS FOR CADETS**  
**REOPENING OF SCHOOL AFTER SUMMER VACATION - 2025**

1. Please refer to the School Daily Routine Order No. **279/2025** dated **08 Apr 2025**.
2. The School will re-open (Post-Summer Vacation - 2025) on **28 Jun 2025**. The reporting time for Staff and students is as under:-

(a) Senior Master, House Masters/Hostel Supdt and Cadets will report on 28 Jun 2025 (FN).

(b) Balance Vacational Staff will report on 30 Jun 2025 (FN).

3. The schedule for arrival/reporting of cadets to the School is as under. Cadets are to strictly adhere to the reporting timings as mentioned below. The same will **NOT BE CHANGED UNDER ANY CIRCUMSTANCES**.

4. Cadets are to report with not more than a single escort (either parent or guardian). Vehicle of parents shall NOT be permitted to enter the School campus.
5. As per CBSE norms, 75% attendance is mandatory during an academic session, for a student to be eligible for appearing in examination. You are advised to send your ward to report to the School on 28 Jun 2025.
6. The School will not be responsible for poor academic performance of your ward and also his debarment from appearing in the examinations to be conducted in this Academic Year 2025-26 for less than 75% physical attendance in the School.
7. Boy Cadets are to be in **Zero Cut** on reporting to the School. A picture of the ideal cadet's haircut is attached as **Appendix 'A'** for reference & compliance. Girl Cadet are to be in proper haircut as applicable.
8. Cadets are not to step out of the campus under any circumstances, for any reason whatsoever. **CADETS WHO VIOLATE THIS DIRECTIVE WILL BE LIABLE FOR WITHDRAWAL FROM THE SCHOOL ON DISCIPLINARY GROUNDS.**

9. **Possession of mobile phones by Cadets is strictly prohibited.** Attention of the Parents / Cadets is drawn to **Sainik Schools Society, New Delhi** letter No17/IO/SSS/08 dated **30 Jul 2008** and instructions thereon conveyed by Principal during **Parents Teacher Meet (PTM)** on **28 Oct 2023** that in case of mobile phone is confiscated from a Cadet a fine of ₹ 5000/- will be levied and the same will be deducted from the IRLA of the Cadet. Parents are requested to strictly ensure the same in letter and spirit.

10. **Cadets will not be allowed to enter the School without full payment of due fees.**
