SAINIK SCHOOL CHITTORGARH VIRTUAL PARENT-TEACHER MEET MINUTES

The virtual PTM of class XI for the academic session 2024-25 was held on **20 Dec 2024** in the NDA Hall at 1000h. It was presided over by **Lt Col Parul Srivastava**, **Vice Principal**, **Sainik School Chittorgarh**. The following points were discussed:

Ser	Points	Brief
1.	Welcome address	Lt Col Parul Srivastava, Vice Principal, welcomed the parents on behalf of Sainik School Chittorgarh fraternity and highlighted the importance of PTM and the role of parents in the performance of their ward. She conveyed that the need of this PTM aroused because Cadets performed very poor in PT III exam. She also informed parents that in addition to regular study hours in the school, cadets were provided with extra classes and the revision classes, but then too they have left their sheets blanks because they are having a mindset that the marks of class XI are not added anywhere.
		(a) Class XI is the base of NDA. She informed parents that class XI is the base of NDA exam. If they will not study properly how they will be able to clear the written exam.
		(b) Motivation and encouragement from parents side She asked parents to motivate and encourage their child as school does not want to fail anyone. Parents cooperation is equally needed for better result.
		(c) Information about Annual Exam question paper In addition to this, parents were informed that Annual Exam question papers comes on behalf of sainik schools society and if the cadet do not perform well in exams he/she will fail.
2.	Declaration of PT III examination Result	Mr Manjit Singh, I/C Exam Cell, announced the marks of cadets. Parents also interacted with Subject teachers and House Masters to learn about the academic progress and conduct of their ward in school.
3.	Points raised by parents	The following points were raised by parents and discussed in the PTM :-
		(a) School No. 5858- Cadet Vikas – Kumbha House:- Parent of the cadet demanded that result should be informed to parents regularly because cadets misguide their parents about their marks.
		Action taken: Vice Principal replied that he got only passing marks in his subjects. School is putting a lot of

efforts but he is not concentrating on studies.

(b) School No. 5940- Cadet Rishikesh Sharma – Hamir House

Parent of the cadet demanded to know about the performance of his ward.

Action taken: Vice Principal replied that he is not attending the NDA classes intentionally. He failed in Maths and bunk a lot of classes. House master also informed parent about his misconduct and irregularity.

(c) School No. 5964- Cadet Siddarth – Pratap House Parent asked for his report and told that his poor performance is because he does not want the subject he is given.

Action taken: Vice Principal replied that he is on the verge of failing and not informed anyone, neither the house master nor the administration about the subject related issue, which the parent is addressing. She also informed that subjects are allotted to the cadets according to the availability of seats and marks the cadets have scored. The instructions of allotment of subject in class XI vide letter No 233/3 dtd 10 Jan 2024. In this regard parents are herby informed that admission to the cadets in class XI will be given on the basis of merit of class X.

(d) <u>School No. 5934- Cadet Aryan – Pratap House</u> Parent said that phone has also been given to the ward to study, then too they are not producing any result.

Action taken: Vice Principal replied that they misuse phone and use it for entertainment purpose. She requested to take the phone back.

(e) <u>School No. 5951- Cadet Rahul Gurjar -Kumbha</u> House

Parent requested for less involvement of cadets in games and co-curricular activities so that they can focus on studies.

Action taken: Vice Principal replied that co- curricular activities are equally important for their holistic development as when they appear for SSB they are asked about it. Cadets are given sufficient time for both studies and extra activities.

(f) <u>School No. 5922- Cadet Dilkesh – Badal House</u> Parent asked about the performance of their ward and said that as it is a residential school, and cadets come to them for a very less time, they are unable to motivate them.

Action taken: Vice Principal asked their contribution in cadets academics. Regular PTM'S are scheduled and they do not attend them, how they will know about their wards progress. Only four parents of class XI attended the last PTM. School is putting efforts but there is very less contribution from the side of parents.

(g) <u>School No. 5951- Cadet Vishal -Badal House</u>
The parent expressed his heartfelt gratitude to the vice principal for organizing this PTM as it is very helpful to them for knowing the progress of their ward. In addition to this the parent asked when they can come to meet the Vice Principal to discuss their queries.

Action taken: Vice Principal appreciated the parent and assured every parent that if they have any query or want to meet administration, they can come to school on working days after giving prior information of their arrival to the house master, as housemaster is the key between parent and school administration.

(h) Some parents raised question as now what should be done to improve the performance from their side.

Action Taken: Vice Principal requested that parents should be in touch with cadets and encourage them to study. Attend regular PTM'S. Three months are left in Annual Examinations; if the cadet will study properly no one will fail. The NDA classes which are scheduled are for the betterment of the cadets which is more like a revision of their subjects.
